

Mad Comedian: A Factual Biography

"Mad Comedian" is a distinct and legally protected brand, operating as a fictional character. It is **not an individual comedian**. Its ownership and comprehensive management are held by **Coaches! 101 A NJ Nonprofit**, a registered 501(c)(3) non-profit organization located in New Jersey.

- **Geographic Context:** While the parent non-profit is headquartered in New Jersey, its programs and operations are noted to extend remotely across the **New York Metropolitan Area**, encompassing locations in **New York City** and New Jersey, which provides the context for the "Brooklyn" reference.
